WATERSHED MANAGEMENT ADVISORY COUNCIL**

Regular meeting of January 25, 2016

Randy Peck called the meeting to order at 7:30 pm.

The Committee members reviewed the minutes from the December 28, 2015 meeting. A motion was made by Gary Orbaker to approve the minutes as submitted, seconded by Kurt Allman. All were in favor. Motion passed.

**New business:**

- Stephen and Susan Schoen, 2787 Rosemarie Lane: An application made by Mr. and Mrs. Schoen for exemption from drainage tax was reviewed by the Drainage Committee. The Schoen's submitted photos of the work completed and two invoices totaling \$600.00 for excavating work done.
- Stephen Harden, 2809 Rosemarie Lane: An application made by Mr. Harden for exemption from drainage tax was reviewed by the Drainage Committee. Mr. Harden also submitted an invoice total \$165.00 for excavating work done.

A motion was made by Kurt Allman to recommend approval of the applications, seconded by Gary Orbaker. All were in favor, motion passed.

- John Kiernan, 2709 Ridge Road: Judy Champion appeared on behalf of her father John Kiernan. Mr. Kiernan is subdividing one lot into two. He will be transferring ownership of one lot to Ms. Champion for estate planning purposes. There are no plans at this time for construction on the lot.
- Wayne Co. Soil & Water: Gary Orbaker presented a brief update from Lindsey Gerstenslager. A draft maintenance program of Salmon Creek West was also provided. The beavers that are currently being trapped may be coming from the DEC wetlands nearby. They continue to be trapped and dams continue to be removed from the creek. Per Lindsey, DEC will allow maintenance in Section I in July and August only. Lindsey is working on compiling a list of contractors for the county.

- A motion was made by Kurt Allman to recommend to the Town Board to pay Invoice #152 totaling \$9,398.57 from Wayne County Soil & Water. The motion was seconded by Gary Orbaker. All were in favor, the motion passed.

- Jim Stohr, 7104 Tuckahoe Road: Final grading still needs to be done.
