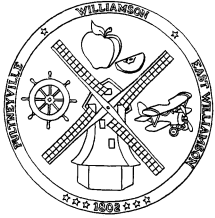


Peddler Permit Process

1. Applicant completes top portion of Application
2. Clerk completes bottom portion
3. FEES:
 - \$25.00 per day, per person
 - \$100.00 per year, per person
3. We will need have a copy of each person's driver's license
4. Applicant will get bottom portion of application, it MUST be displayed in automobile, in a very conspicuous place.
5. **EVERY PERSON INVOLVED NEEDS TO HAVE A PERMIT!**

- c) Conducting peddling or solicitation activities contrary to the provisions in the permit.
- d) Conviction for any felony, or any violation of the Town.
- e) Conducting peddling or solicitation activities in an unlawful manner or in such manner as to create a public nuisance, constitute a breach of the peace or endangering the health, safety, morals, or general welfare of the public.
- f) The failure or inability of an applicant to meet and satisfy the requirements and provisions of this code.
- g) Any fees paid are non-refundable.
