Appeal No. 769. Michael Havens of 7215 Fisher Road, Ontario, NY 14589. A request for an area variance for side setback relief for a proposed attached garage and deck. Property is owned by the applicant and is located at 3467 Lake Breeze Drive, Williamson. Zoned R-1.

David Matthews, from Shelley Associates, P.E. addressed the Board on behalf of Michael Havens. He indicated that Mr. Havens will be demolishing the existing home and rebuilding a new home on the existing footprint. The existing house is non-conforming to sideline setbacks. Mr. Havens wishes to add an attached garage and deck to the new home, which will be in line to the new home. The existing house and proposed garage and deck are 6.5 feet from the west property line and 12.8 feet from the east property line. Chairman Peters questioned Mr. Matthews how far the neighbor's house to the west was from his lot line. He indicated he wasn't sure. Chairman Peters asked if there was any public comment or concerns on this matter. There were none.

There being no further discussion, Kurt Allman made a motion to grant Appeal No. 769 with 9 feet of relief on the west lot line and 2.7 feet of relief on the east lot line. Jordan Szklany seconded the motion. Upon roll call vote, all voted in favor of the motion.

Steve Haywood asked Chairman Peters if he would like to sit in on a meeting with Kim Baptiste from Bergman Associates in March to discuss zoning.
