## **Unfinished Business:**

- Mark Lagoner, Tuckahoe Road Drainage Issue: Nothing new to report.
- Jim Stohr, 7104 Tuckahoe Road: Gary to check property
- Rick Vos., 7487 E. Townline Road: Nothing new to report.
- Ridge Road/Salmon Creek: This project is on the County's 2015 project list
- Ridge Chapel Road: Nothing new to report
- Timothy Dostman, 4530 New Road: Work should be completed once property is drier. Kurt expects this to be done in August due to other Town projects.
- Brenda Christy, 5745 Eddy Ridge Road: The jet rodding has not been done yet as the request to use the jet rodder still needs to be presented to the Town Board for approval. Randy to talk to town supervisor.
- David & Denise Brandon, 2894 Kenyon Road: Sara Gilbert appeared with the Brandon's to present an updated site plan showing culverts as requested by the Drainage Council in April. The updated site plan, dated April 28, 2016, was presented to the Planning Board and given approval by them pending the following changes: 1. a swale to be dug to help with drainage. 2. The sand filter is to be relocated. There were no changes to the grading of the property other than the swale and sand filter. A motion was made by Rick Vos to recommend approval to the Planning Board of the updated site plan (dated April 28, 2016) presented to the Drainage Council on May 23, 2016, seconded by Jay Peters. All were in favor, motion passed.

## **Council project planning/administrative work session:**

Gary reported that the Stream Maintenance Plan was presented to the Town Board at the April 26 meeting but not adopted. The Board Members wanted time to read the plan. He hoped it would be adopted at the meeting May 24.

Discussion took place regarding using town equipment on private property. Rick questioned why work couldn't be done if property owner has no problem with equipment being used. He was reminded that town equipment cannot be used on private property. He pointed out that fire departments responding to fire/ems calls use equipment funded by town taxes with no problems.

Dale Bushart, Tuckahoe Road, has maintained the ditch behind his house on his own. Debris has been thrown in that ditch, causing water to back up onto his property. Discussion took place on the need to do continued maintenance.

Rick Vos made a motion to adjourn the meeting at 7:55pm.
