The motion was carried.

Dave Frohlich made a presentation on wanting to change the town Alcohol Control Statute. At this time our town only allows the retail sale of beer. A committee has be formed to help in this process. He spoke of this being a two step process, one being a petition drive to get a proposition on the ballot for the general election. If the petition drive is successful the proposition will be placed on the November General Election Ballot, as a referendum, for the voters to decide. The most important distinction he wanted to call to attention, is the fact that the town law can be changed to allow only restaurant licenses and exclude taverns. Coincidentally, the law may also be amended to allow for a package store which again existing law disallows. They believe that changing the existing local law would enhance economic development opportunities for the Town of Williamson. The committee believes there is a solid opportunity to attract one or more fine restaurants to locate in our town. Allowing on premises consumption will also open the possibility for the development of a golf course. Farm wineries also represent another potential for economic development. By excluding taverns from these recommended changes, they believe they can guard against negative changes in the quality of life issues which are vitally important to the towns overall well being.

The Board is still waiting to hear from the town attorney about the proposed park fees.

Councilman Verno made a motion, seconded by Councilman Orbaker to increase the charge for replacement of frozen water meters from \$25.00 to \$65.00. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Warren to authorize the Town Clerk to advertise in the Sun and Record issue of February 12, 2004 for applications for a meter reader position. Applications will be accepted until February 23, 2004 at 4:00 p.m. Pamela Wren has terminated her employment with the Town of Williamson The motion was carried. Councilman Verno made a motion, seconded by Councilman Orbaker to authorize Joe English to attend a pesticide training class for certification. The class is to be held at the Cooperative Extension in Newark, New York. The registration fee is \$45.00 with all other necessary and actual expenses to be a town charge. The motion was carried.

The Board discussed insurance for the Apple Blossom Festival. A motion will be forthcoming at the next board meeting regarding insurance coverage by the town for this event.

Public Comment – Mr. Herbert received a call during the meeting, taking a complaint about the Highway department dumping snow in a residents flower bed.
