NOW THEREFORE BE IT RESOLVED: That pursuant to Chapter 135 of the Williamson Town Code, the Town Board hereby authorizes the Town Forces to enter upon the property of Glen Houle located at Nos. 3880 and 3888 Railroad Avenue in the Town of Williamson, tax account Nos. 65117-07-679879 and 65117-07-697875 on or after April 14, 2008 for the purpose of ameliorating the Code violations set forth in the report submitted to the Town Board by the Code Enforcement Officer dated January 18, 2008 and that the cost of ameliorating the code violations shall be levied and collected in the same manner as provided for in the Town Law for the levy and collection of town taxes or special ad valorem levies.
