Councilman Bixby made a motion, seconded by Councilman Orbaker, to authorize the Assessor's Clerk to attend an RPS V4 Training class – "RPS V4 Tentative and Final Roll Preparation", to be held at the ORPTS Batavia Regional Office on Thursday March 14, 2013. There is no registration fee for this class, with all other necessary and actual expenses as a Town charge. The motion was carried.

Supervisor Hoffman presented the following Resolution and moved its adoption. It was seconded by Councilman Verno.

WHEREAS: The record books of the Justices, Town Clerk, and Supervisor were made available to the Town Board prior to this meeting, and

The position will be for no more than 18.5 hours per week. Discussion ensued. Councilman Orbaker amended the motion, seconded by Councilman Verno to include a rate of \$20.00 per hour. The amended motion was carried.

Councilman Verno made a motion, seconded by Councilman Bixby, to authorize the Town Supervisor to sign a maintenance agreement with Lang Heating/ Cooling for the boilers at the Water Treatment Plant. The cost for this service is \$273.00 beginning 3/1/2013 and will expire on 3/1/2014. The motion was carried.

WHEREAS: The Town of Williamson desires to purchase a new Ford F-450 pickup truck; and

WHEREAS: The Chatauqua County Department of Public Affairs has previously solicited bids for the purchase of various vehicles including the Ford F-450 pick up truck; and

WHEREAS: The Chatauqua County Department of Public Affairs has reviewed all bids and has made an award to the lowest responsible bidder which bid award is open to all political subdivisions within the State of New York; and

WHEREAS: The Town of Williamson, wishes to purchase a Ford F-250 pick up truck off of the Chatauqua County contract;

NOW, THEREFORE, BE IT RESOLVED: That the Town Supervisor or the Town Highway Superintendent is hereby authorized to purchase a 2013 Ford F-450 pick up truck off of the Chatauqua County contract in the amount of \$52,317 and for such purpose to execute the appropriate documents to complete the purchase of the vehicle.

Bill Dobie and Ted Kerschner will be attending. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Bixby, to allow the attendance at a training class given by the Ontario County Soil & Water Conservation District and the NYS DOT. The course will be held on Tuesday, March 26, 2013 at the Ontario County Training Facility in Hopewell. The cost for this course will be\$100.00 with all other actual and necessary expenses as a town charge. The motion was carried.

Councilman Orbaker presented the following Resolution and moved its adoption. It was seconded by Councilman Verno.

WHEREAS: THE Town of Williamson currently has an undertaking with NYS DOT which is no longer valid due to recent changes in the form and content of the document, and

WHEREAS: the Town still wishes to use an undertaking for the purpose of indemnification pertaining to work performed within the New York State right-of-way under future valid highway work permits,

NOW, THEREFORE BE IT RESOLVED: the Town Supervisor is authorized to sign the Undertaking and a copy will be mailed to NYS DOT for filing.

Councilman Orbaker made a motion, seconded by Councilman Verno, to appoint Mike Bixby-Councilman, Gary Orbaker-Councilman, Kurt Allman-Superintendent of Highways and Brian Frey-WC Assistant Engineering Manager, to serve as a selection committee to review the RFP's, after they have been received, for a consultant for the Williamson Safe Route to School project. The motion was carried.

Supervisor Hoffman discussed that prices had been researched regarding the core boring at the Town gravel pit in the Town of Sodus. The price range came in from \$6,900 - \$8,200. The Board agreed to ask Wayne County Soil & Water Dept. for their help in doing this.

Councilman Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Orbaker.

WHEREAS: The Town of Williamson wishes to enter into a Professional Services contract with Larsen Engineers for the design, build and installation of control systems and components at the WWTP at a cost not to exceed \$95,000.00, and

WHEREAS: The Town of Williamson will be bidding the materials portion of the project,

NOW THEREFORE, BE IT RESOLVED: The Town Supervisor is hereby authorized to sign said agreement with Larsen Engineers.
