Robin McCowen and Jacqueline M. Klahn with the USDA explained what will be taking place between mid April and mid September of this year regarding the surveying and testing of the "Plum Pox Virus" problem in Williamson. Ms. Klahn informed The Board concerning the importance of this virus. These tests are being done all over the country in order to contain and eradicate it. Incidents were found in Wayne, Orleans, Niagara and Monroe Counties in 2008. Once this virus has been detected in an area and taken care of, it needs to be retested the next year and monitored for three years. Ms. Klahn indicated once they retrieve the samples of leaves from Prunus trees (stone fruit trees), they are sent to Cornell Geneva Sub-station for testing. Surveyors with the U.S. Dept. of Agriculture will be inspecting properties for Prunus sp. Plants/trees (fruit trees and ornamentals). These surveyors will need access to private property to sample the leaves and will be carrying official identification. Letters will be sent out to all residents asking permission to collect sample leaves for testing. Residents will need to contact the main USDA office located in Lockport, by the web site or call for an appointment for permission to survey their property or set up an appointment for the inspection. The USDA personnel will also be leaving door hangers with this information. The USDA is asking The Town of Williamson to lease space for this operation. A report will be completed sometime in October.

A notice having been published for a Public Hearing regarding proposed Local Law #1-2009, Amendment to Chapter 178 Zoning – Article 7, Supplementary Regulations Governing Certain Uses, Section 175-25 "Miscellaneous uses; signs", Paragraph D (2)(c). Supervisor Hoffman declared the Hearing open at 7:31 PM. The Supervisor explained the amendment is to permit scrolling signs at designated places. Questions and comments were heard from: Jackie Walker, Faith Supersad, Tom DeMarree, Lenore Youngman, and Wilma Young. Schools are regulated by the NYS Education Law and do not need zoning approval to have these signs. Amending the law would make it more convenient for the public buildings named in the law to change information to the public as needed. The Zoning Officer/Code Enforcer will approve what is allowed, per the zoning laws in the Town of Williamson. Any applicant or aggrieved property owner may appeal the Zoning Officer's decision to the Zoning Board of Appeals. After hearing from everyone who wished to comment or ask questions, the Public Hearing was closed at 7:50 PM on motion by Councilman Verno, seconded by Councilman Orbaker. The motion was carried

The Town Clerk will be able to mark the appropriate spaces signifying what the person has paid for, such as \$30.00 for refrigerators, freezers, dehumidifiers and air conditioners or \$5.00 for car/pickup tires up to 750 x 20, \$9.00 for larger truck tires, and \$14.00 for tractor tires. The post cards will also be marked to show how many trips have been made, up to a maximum of three trips.
- f. pay the Library bills as audited by the Library Board of Trustees: vouchers 467 485, total \$11,705.31

Councilman Verno made a motion, seconded by Councilman Warren, to authorize two employees to attend a Notary Training Class and to authorize the attendance of up to 6 employees to attend a class that will review changes in laws that effect notary procedures, these classes are to be held at Tobey Village Office Park, Pittsford, New York. The costs for these classes are \$99.00 per person for new notaries and \$49.00 per person for the refresher course. The motion was carried.

FYI – We currently notarize documents by public request. This is a courtesy service the Town provides.

Councilman Verno made a motion, seconded by Councilman Orbaker, to authorize Paula Datthyn, Assessing Clerk, to attend a seminar on Appraising at Cornell University in Ithaca, New York from July 13 through July 17, 2009. The cost for the seminar will be \$510.00 with all other necessary and actual expenses as a Town charge. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Warren, to authorize the Building Inspector to attend a continuing education seminar sponsored by RG & E to be held in Rochester, New York on Friday, April 17, 2009. The cost for the seminar will be \$15.00 with all other necessary and actual expenses as a Town charge. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Warren to advertise in the Sun & Record & Times issues for the week of March 29, 2009 to receive applications for temporary part-time employees to work with the outside crew in the Water Department. Applications will be accepted until April 10, 2004. Bill Dobie, Outside Working Foreman, is authorized to hire up to three people after the acceptance date for applications. They can begin working as soon as needed and will work on an as needed basis.
