Public Comment: Kurt Allman; Highway Superintendent, announced that the remaining salt that the Town is committed to purchase, must be picked up by August 31st. He is looking into options for storage of the salt.

Chris Pavlick; Plant Manager for Thatcher Company of New York, presented their 2011 Annual Report. The Company has been in operation for 22 years and again last year had a sales increase. In 2011, three outside audits were conducted. One was by the Town of Williamson Water Department, the second by Underwriters Laboratory quality audit for drinking water additives, and the third was by the Bureau Veritas quality audit for certification to ISO 9001:2008 standard. In addition, two customer quality audits were conducted and two vendor safety and process audits were conducted. The staff for 2011 included 4 chemists and 1 engineer. The Company has now implemented its Site Security Plan (SSP). The SSP is a requirement under the new Chemical Facility Anti-Terrorism Standard issued by the Department of Homeland Security.
