The motion was carried with all those present voting Aye, except Councilman Watson who abstained.

Supervisor Hoffman made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign the annual software support contract with Williamson Law Book Co. for technical and software support for the payroll program. The cost for this support contract will be \$660.00 per year. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Bixby, to authorize the Town Clerk to advertise in the Town's official papers the week of April 24, 2011 for a Public Hearing to be held on May 10, 2011 at 7:30 PM. Councilman Verno made a motion, seconded by Councilman Bixby, to authorize two Water Dept. personnel to attend a NYRWA seminar to be held in Saratoga, New York May 9 - 12, 2011. The registration fee is \$325.00 per person with all other necessary and actual expenses as a Town charge. The motion was carried.

Public Comment: Phil Dean thanked the Board for his recognition. He then discussed a drainage problem on Wayne Street involving the Manktelow property located west of Route 21. The culvert located there goes from a fifteen inch into an eight-inch pipe, which is creating a problem and needs to be changed. An easement has been obtained from the Colern property, which is east of Route 21.
