Councilman Orbaker made a motion, seconded by Councilman Bixby to authorize the Town Supervisor to sign the Farmland Protection Implementation Contract with the State of New York Department of Agriculture and Markets. The motion was carried.

Supervisor Hoffman made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign the annual software support contract with Williamson Law Book Co. for technical and software support for the payroll program. The cost for this support contract will be \$660.00 per year. The motion was carried.

FYI - This is the same cost as last year.

Supervisor Hoffman made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign banking agreements with Key Bank and Chase Bank. The motion was carried.

Councilman Watson made a motion, seconded by Councilman Verno, to authorize up to seven members of the Planning Board to attend the Spring Local Government Workshop to be held Friday, May 14, 2010 at the Burgundy Basin Inn in Pittsford. The registration fee is \$50.00 per member with all other necessary and actual expenses a Town charge. The motion was carried.

Councilman Watson suggested that the Town work on five projects that the Comprehensive Plan has approved. He would like the Town to pursue the following items:

- 1. Zoning
- 2. Williamson Central School: Programs for teens
- 3. Preservation: Look into the Town becoming a certified local Government
- 4. Marketing Plan
- 5. Farmers Market

The Board discussed and agreed to look into all five projects. They also agreed that they should start to send letters and advertise for people to join committees for each project.

Public Comment: Nancy Jordan asked if the Town was planning another electronics recycling day for this year. Supervisor Hoffman stated that, "yes", and he believed the date was August 14, 2010. Questions and comments were heard from Jackie Walker, Perry Howland, and Fedele Noto regarding the farmers market.

Gary Orbaker gave a Drainage Council meeting update. He spoke about a drainage issue on Rosemarie Lane, Deliverance Ave, where there are trees growing in a drainage ditch causing problems, and they may be on Town land. He also commented on Lisa Hoteling, from Church Road, and that they would like to look into hiring a land surveyor firm to make some suggestions for her drainage issues.
