WHEREAS: The other bid was from Villager Construction, Inc. in the amount of \$889,000.00 and it does meet the bid requirements,

WHEREAS: The lowest and only bid that also met bid requirements for Contract #2 was from Schuler-Haas Electric Corp. in the amount of \$128,600.00,

NOW, THEREFORE, BE IT RESOLVED: That the bid for contract #1 be awarded to Villager Construction, Inc. for \$889,000.00 and Contract #2 be awarded to Schuler-Haas Electric Corp. for \$128,600.00, and

BE IT FURTHER RESOLVED: That the Town Supervisor is authorized to sign Notice of Award documents for each awarded bid.
