Ora Rothfuss from Wayne County Planning updated The Board on the Farmland Protection Grant Paul and Doug Mason are in the process of applying for. The total amount of the project is \$550,000. Last fall an application to the State was submitted for 75% [\$417,000] funding for selling easements to be kept for agriculture purposes only to the Town. Since last fall because of the economic crises, the State has dropped its total funding for this grant from thirty-two million to seventeen million, and no grant has yet been awarded. Federal funding has now become available toward the purpose of this grant. The Federal funding amount needed for the Mason Farm Project is \$140,000 and the application deadline is June 1<sup>st</sup>, 2009. There is no cost for the Project to the Town. At this point if the State funding does not come through, the Federal application will not be submitted.

Councilman Bixby presented the following Resolution and moved its adoption. It was seconded by Councilman Verno.

WHEREAS: The Town of Williamson applied to the NYS Department of Agriculture and Markets farmland protection program on behalf of the Mason family,

WHEREAS: Upon receiving adequate funding being awarded to the project, the Town intends to partner with the Genesee Land Trust in the monitoring, stewardship and enforcement of a conservation easement on the Mason Farm,

NOW THEREFORE BE IT RESOLVED: That the Town fully supports the application on behalf of the Genesee Land Trust to purchase an agricultural conservation easement with the Genesee Land Trust from Paul and Doug Mason, as part of the USDA NRCS farmland protection program, pending an award from NYS Department of Agriculture and Markets farmland protection and pending approval by the Town attorney for form and content.
