Public Comment: Ted addressed his concerns on the Zoning Local Law regarding how restrictions in livestock fence height and distance from the property line in the current Town Code had to be. After contacting the State, he found that the State Ag. Law stated a livestock fence was permitted on the property line as long as the wire is accessible. He also found out that Williamson was one of two towns in the entire state that required a permit to install a fence in an Ag District. He felt there should not be such restrictions in an Ag District as Williamson is an agriculture community. After discussion by the Board, Supervisor Hoffman explained the process of changing the Zoning Law. The Board agreed his request will be sent to the Planning Board for review and depending on their recommendation, be reviewed by the Town Attorney and then come before the Town Board for a decision. The Board asked Mr. Peters to bring in copies of his findings for the Planning Board to review. WHEREAS: We believe that our response to climate change provides us with an unprecedented opportunity to save money, and to build livable, energy-independent and secure communities, vibrant innovation economies, healthy and safe schools, and resilient infrastructures, and

WHEREAS: We believe the scale of greenhouse gas (GHG) emissions reductions required for climate stabilization will require sustained and substantial efforts, and

WHEREAS: We believe that even if emissions were dramatically reduced today, communities would still be required to adapt to the effects of climate change for decades to come,

NOW, THEREFORE, BE IT RESOLVED: That the Town of Williamson, County of Wayne, in order to reduce greenhouse gas emissions and adapt to a changing climate will

1. Pledge to be a Climate Smart Community

WHEREAS: The Town Board has initially identified a number of agencies which would appear to have an interest in the Project and in participating in the SEQRA review process, which list is attached hereto and made a part of this Resolution, NOW, THEREFORE, BE IT RESOLVED: By the Town Board of the Town of Williamson, Wayne County, New York, as follows:

1. The Town Board hereby accepts the Environmental Assessment Form, as prepared.

2. Based upon the Environmental Assessment Form and the factors recited above, the Town of Williamson hereby declares its intention to act as Lead Agency for the purposes of conducting a review under the State Environmental Quality Review Act (SEQRA) with regard to the Project since the environmental, social and economic impacts of the Project will primarily be of local significance. 3. The Town Board hereby authorizes and directs its Town Clerk to forward copies of this Resolution to interested or involved agencies with the request that such agencies notify the Town within 30 calendar days if they have any objection to the Town Board acting as Lead Agency in this matter.

4. The Town Clerk is directed to maintain for public inspection a file containing a copy of this Resolution, all submissions to date and all further communications or correspondence which the Town may receive concerning this matter from other interested agencies or parties.
