Supervisor Hoffman discussed with Attorney Art Williams the issue of spending drainage tax dollars on private drainage projects. Attorney Williams feels that this could be done with a Board Resolution but is checking into it and will get back to the Supervisor.

Councilman Orbaker stated that Thomas VanDeWalle who resides on Lake Avenue came to the Drainage Council meeting last night with a serious drainage problem in his yard and basement. The problem has existed for years. After discussion, The Board agreed to have the Sewer Department take their camera to find out where all the water is coming from.
