Councilman Warren mentioned the Legion ball field at the Town Park has been completely seeded by the Wayne County Soil and Water Conservation Department. Baseball activity at the Park is just as busy as Soccer activity this year.

The Board discussed the energy audit report done by C.J. Brown Energy, P.C. on the new Town Complex. The report indicated that the building is energy compliant but the roof should be looked at. It also stated that water source heat pump systems, which is what the complex has, costs twice as much to operate as the conventional systems.

Councilman Monsees commented on the concerns that residents had on the handicapped parking accessibility areas being so far away from the complex entrances. The Board discussed options and felt the Town Complex Governing Committee should research the options and costs if changes are to be made. They felt at this time the roof on the building due to ice build up in the winter was a priority.

Councilman Orbaker reported on the Drainage Committee meeting. They have received a majority of the easements needed to start the clean-up project for Jack (Tack) Creek. The county has four contractors to choose from that the Town can use for the project. The committee has approximately \$42,000 to work with.

Councilman Verno made a motion, seconded by Councilman Monsees to authorize the Town Clerk to advertise in the July 7, 2005 issue of The Williamson Sun and Record for a Public Hearing regarding proposed Local Law #2, Power Generating Windmills. The Public Hearing will be at 7:30 p.m. on July 26, 2005 as part of the regular town board meeting. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Orbaker, to authorize the Town Clerk to advertise in the Williamson SUN issue of June 30, 2005, to receive bids for materials for the East Townline Road, from Ridge Road to existing main south of Congdon Road, and an extension along Pearl Street, watermain construction. Bids will be received until July 20, 2005 at 2:30 PM at which time the bids will be opened. The town board reserves the right to reject any and all bids. The motion was carried.

Public Comment: Bill Herbert commented on how lucky people in our county are after just coming back from Brazil where there is so much chaos.
