WHEREAS: The litigation costs of these challenges may be more than the Town can anticipate and afford, the County of Wayne has adopted a policy of participating in the costs and expenses of such litigation and has approved the above litigation for county, town and school participation by resolution 939-09 dated November 17, 2009, and

WHEREAS: Subsequent actions have been commenced by the petitioner for the same property for the year 2015, and

WHEREAS: The prior policy of the County was to include subsequent challenges to the same property without additional resolutions so long as the amounts at issue remained within the parameters set by the County, and

WHEREAS: By e-mail dated July 30, 2014 the County Attorney notified Town Assessor that the resolution was limited by its terms to index number 68622 so that additional resolutions should be obtained to avoid any question of participation, and

WHEREAS: Rite Aid Corporation has filed grievances, after receipt of the decision by members of the Williamson Board of Assessment Review, claiming excessive and unequal values against the assessment for the property listed below and request the following assessment rolls be reviewed, and

BE IT FURTHER RESOLVED: That proceedings will involve the County Attorney and Real Property Tax Services Director as consultants regarding appraisals and/or settlement strategies, and

BE IT FURTHER RESOLVED: That the Town of Williamson hereby requests approval for county school participation in this litigation commenced under the index numbers set forth above for the year 2015.

The permit will allow the Town of Williamson to transport raw sewage or dried sledge to the Town of Williamson WWTP or Town of Ontario WWTP. The permit is an annual permit and the permit fee is \$250.00. The motion was carried.

Councilman Verno stated a recent meeting with the Williamson Central School Superintendant, Wayne County Director of Real Property, Town of Williamson Library Board Chairman, Supervisor Hoffman and himself to discuss when the Library budget will appear on the Williamson Central School tax bill. He announced it will appear on this year's school tax bill [2015-2016]. Fifty three (53) properties in the Town of Marion and sixteen (16) in the Town of Sodus will now receive a Williamson Library tax in addition to receiving their own Town Library tax. According to the Director for Real Property, it is a glitch in the State system that no one can change.

Councilman Bixby announced a meeting is scheduled on August 12<sup>th</sup> with the Williamson Central School Superintendant, Supervisor Hoffman and himself to discuss the use of park fields by the school athletic departments.

The Board discussed the bids received for watermain materials and agreed to address it at the next Town Board meeting.
