Public Comment: George Harland gave an update on Park projects. He also stated that there are quite a few items in the lost and found at the park. George explained that there have been 7 Eagle Scout projects completed at the park; Anthony Verno III completed the latest. George Harland and Elliott Warren both commented on how much they enjoyed working with Anthony.

The motion was carried.				

Steve Haywood introduced Cindy Baire; Vice President, GAR Associates. He explained that GAR Associates is an outside agency that performs impartial, objective valuations of real property. He would like the Board to consider them to do the re-valuation for the Town in 2007. Cindy gave a presentation to the Board where she explained exactly what her Company does and how they operate. Questions and comments were heard.

Supervisor Hoffman made a motion, seconded by Councilman Orbaker to declare the 1994 F250 Ford 4x4 Pick-up with a plow as surplus. The truck has 97,151 miles and needs rear brakes and brake lines. The truck can be examined by calling the Wastewater Treatment Plant at 589-9371. The Town Clerk is directed to advertise for sealed bids containing a non-collusive certificate. The advertisement will be in the Williamson Sun & Record on September 1, 2005 with bids being accepted until September 21, 2005 at 4:00 p.m. at which time the bids will be opened and read. The motion was carried.

Councilman Monsees made a motion, seconded by Councilman Verno to advertise in the Sun & Record issue of September 1, 2005 for applications for an upcoming opening on the Board of Assessment Review. Applications will be accepted until September 15, 2005, at 4:00 p.m. The motion was carried.

There was a short discussion concerning the proposal from Wayne County Water and Sewer Authority to upgrade the Williamson Pump Station located on Route 21. WCWA wanted the modification to be done by fall this year, so they can purchase as much water as possible before years end. Mike Schaffron talked to Marty Aman at WCWA and explained to him that the modification would not be able to start until the end of November at the earliest. WCWA decided that there was no hurry to get it done if it could not be done this year.

Councilman Verno made a motion, seconded by Councilman Warren to hire Paula Datthyn for the position of Secretary to the Zoning Board. Start date will be August 2005 with the rate of pay of \$564.00 annually. The motion was carried.

Councilman Orbaker presented the following Resolution and moved its adoption. It was seconded by Councilman Verno.

WHEREAS: The Town Board, at an adjourned meeting held November 12, 1985, established a Capital Reserve Fund pursuant to Section 6-c of the General Municipal Law, to finance the cost of replacement and repairing ambulances, and

WHEREAS: An expenditure not to exceed \$125,000.00 is needed for the purchase of equipment at this time,

NOW, THEREFORE, BE IT RESOLVED: That monies be used from said Capital Reserve to cover expenditures not to exceed the amount of \$125,000.00 to purchase a used ambulance and said purchase shall be made pursuant to the bidding procedure prescribed in General Municipal Law, and

BE IT FURTHER RESOLVED: That this resolution is subject to permissive referendum, as pursuant to Article 7 and Section 90 of the Town Law of the State of New York, that within 10 days from the date of this resolution the Town Clerk shall post and publish a notice which shall set forth the date of the adoption of the resolution and shall contain its contents, and shall specify that this resolution was adopted subject to referendum and shall publish such notice in the official newspaper of the Town of Williamson, and in addition thereto, the Town Clerk shall post or cause to be posted on the sign board of the Town of Williamson, a copy of such notice within 10 days after the date of the adoption.

Roll call vote on the Resolution was as follows:

The Resolution was declared adopted.

Councilman Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Monsees.

WHEREAS, The Town Board of the Town of Williamson shall consider a bond resolution authorizing general obligation serial bonds (and bond anticipation notes in anticipation thereof) to finance certain capital improvements consisting of the acquisition and construction of water improvements for the Town of Williamson Water District; and

WHEREAS, The Town Board has duly considered the nature and scope of the proposed project and financing and the other proposed actions of the Town in connection therewith (the "action");

NOW, THEREFORE, BE IT RESOLVED BY THIS TOWN BOARD AS FOLLOWS:

1. The Town Board of the Town of Williamson is hereby designated as lead agency for the proposed action and therefore responsible for determining whether an environmental impact statement is required under the State Environmental Quality Review Act and the regulations of the Department of Environmental Conservation of the State of New York (6 NYCRR Part 617, as amended) promulgated thereunder ("SEQRA").

2. Based upon the review by the Town Board of the proposed project, the Board hereby finds that the proposed action constitutes a "type II action" as such quoted term is defined in SEQRA and, therefore, is not subject to any further review by the Town under

SEQRA. A listing of such type II actions is attached hereto. The action consists of no contemplated expansion of the existing facilities and the improvements to such facilities will be in the nature of replacement, rehabilitation or reconstruction of the facilities in kind, on the same site.

3. A copy of this resolution shall be placed on file in the office of the Town Clerk where the same shall be available for public inspection during business hours. This resolution shall take effect immediately.

The public hearing will be at 8:00 p.m. on September 13, 2005 as part of the regular Town Board meeting. The motion was carried.

Councilman Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Warren.

WHEREAS: The property owners at 5161 Tripp Road, parcel 67116-00-362882, Sodus has requested permission to connect to the water main on Tripp Road, and

WHEREAS: Permission was granted from the town of Sodus as required,

NOW, THEREFORE, BE IT RESOLVED: That permission is given to said property owners at a cost of 1,500.00 to be paid at the time that they sign the water contract with the Town of Williamson which allows them a  $\frac{3}{4}$  inch tap.
