John Manahan; Wastewater Treatment Plant Chief Operator, Kurt Allman; Highway Superintendent, Monica Deyo; Times of Wayne County, and the undersigned Town Clerk were also present.

Kevin Schulte; with "Sustainable Energy Developments" [SED] gave a slide presentation to the Board regarding the solar project to be installed at the previous landfill site located on Pound Road. In March 2013 a grant from NYSERDA and was awarded to the Town of Williamson in June 2013 in the amount of \$1,033,070. NY SUN Grants are capped at an 11% capacity factor and this project when completed will produce 13.5% capacity factor. After the project is completed, it will provide 100% of the Town's needs. The project will need to be completed in eight months. Mr. Schulte distributed a draft "Solar Energy Power Purchase Agreement" to the Board and for the attorney to review. He will have the final one completed before the next Board meeting for review and has asked the Board to act on it at the next Board meeting.
