Supervisor Hoffman made a motion, seconded by Councilman Warren, to accept the Consent Agenda containing the following items:

Supervisor Hoffman informed the Board a Budget Worksession is scheduled on October 3, 2006 and a Worksession is scheduled on October 4, 2006 to review the RFP's received for the Wastewater Treatment Plant.

Phil Dean asked the Board to consider acting upon a motion from the Drainage Committee Meeting minutes of July 24, 2006. The minutes contain information from Raymond Walvoord for consideration for the Congdon Road and Sherman Avenue neighborhood drainage project. The Board agreed before they can do a resolution for a drainage project, they need a criteria list to follow from the Drainage Committee to use when deciding which projects get funding. As to date, the DEC permit for Jack [Tack] Creek drainage project has not been obtained.

The Town Clerk presented the 2007 Tentative Budget to the Town Board.

Supervisor Hoffman made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign a contract with SWBR for roof remediation work at the Williamson Town Complex. The cost of these services are not to exceed \$42,300.00. The motion was carried.

Dr. Andrew Doniger; Monroe Co. Director of Public Health presented information concerning building a Joint Community Center in the Town of Williamson. A copy of a draft "Phase I Report" created by the Community Center Committee was given to the Supervisor to distribute, review and comment on. The first things that need to be decided before cost and location is what the purpose will be and what amities it will include. These factors will determine the cost and location. After much discussion, it was decided to move forward with creating a survey and getting it distributed in the community. The plan is also, to hold public information meetings to get the feel of what the community wants and ways to fund the project. Dr. Doniger felt more information needs to be collected. Discussion ensued.

Councilman Monsees made a motion, seconded by Councilman Verno, for the Town Clerk to readvertise an upcoming opening on the Board of Assessment Review. The ad will appear in the Sun & Record issue of October 5, 2006 with applications being accepted until 4:00 PM, October 20, 2006. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Orbaker, to authorize the Town Clerk to advertise in the October 12, 2006 issue of The Sun & Record for a Public Hearing regarding LL#2-2006 "Power Generating Windmills – Commercial Wind Farms". The hearing will be held on October 24, 2006 at 7:30 PM as part of the regular Town Board meeting. The motion was carried.

Councilman Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Monsees.

WHEREAS: The Town Board advertised for quotes for proposals for installation by directional drilling of a replacement watermain, and

WHEREAS: Only one quote was received which exceeded the acceptable dollar total for quotes, as per procurement policy,

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Williamson rejects the above mentioned quote, and

BE IT FURTHER RESOLVED: That the Town Board does hereby authorize the Town Clerk to advertise, in the Sun and Record issue of October 5th, 2006, to receive sealed bids for installation by directional drilling of a replacement watermain on the Lake Avenue at Salmon Creek project in Pultneyville.

Bids will be accepted until October 23rd, 2006 at 4:00 PM when they will be opened and read. Roll call vote on the Resolution was as follows:
