Councilman Verno made a motion, seconded by Councilman Bixby, to reappoint Richard Eaton to the Board of Assessment Review. The term of office will be for five years, from October 1, 2010 to September 30, 2015. The motion was carried.

Councilman Watson made a motion, seconded by Councilman Orbaker, to form a Historic Preservation committee with Tom Watson as Chairperson and Bill Clauss, Steve Dunn, Chester Peters, Peter Evans, Dave Frohlich, and Jamie Bishop as members. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Bixby, to hire a contractor approved by the Wayne County Soil and Water bidding process to clean out the existing ditch on Church Road, on the east side of the farm bridge north of the VanHoover property and to repair any damage to the properties caused by the excavation process, with a maximum expenditure of \$6,000.00. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Bixby, to purchase and provide materials including 15 inch pipe, a 4 inch sand tile, adequate crushed stone to bed the pipe a residential concrete drop inlet and topsoil to complete the project on Church Road (including Lisa Hoteling's property). The cost of materials will not exceed \$8,500.00. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Bixby, to hire a contractor approved by the Wayne County Soil & Water Dept. bidding process to complete the work required by the Army Corps of Engineers for the Ridge Road/Salmon Creek tributary project with a maximum expenditure of \$2,000.00. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Bixby, to hire Shelley Associates to supervise the work and submit a report as required to certify compliance with the requirements of the Army Corp of Engineers with a maximum expenditure of \$1,500.00. The motion was carried.

As of today, the work has been completed.

Councilman Orbaker made a motion, seconded by Councilman Verno, to reimburse the Highway Department from Drainage Fund monies for the engineering costs of the Mink Creek project. The total amount to be reimbursed is \$1,382.81. The motion was carried.

Wayne County Soil & Water Dept. has helped in this project and has split the engineering cost with the Town.

Councilman Verno made a motion, seconded by Councilman Bixby, to authorize the Town Clerk to advertise in the designated papers the week of October 3 and October 17, 2010 for a leaf drop off program being provided by the Western Finger Lakes Solid Waste Management Authority. Residents may take leaves to the landfill site on Pound Road on October 23, 30, and November 6, 2010 from 9:00 AM until 3:00 PM. The motion was carried.

The Town Board had discussion regarding amending Public Nuisance Abatement Law. The consensus by the Board was to send it to the Planning Board for final editing and reviewing.

Councilman Verno made a motion, seconded by Councilman Bixby, to authorize the Town Clerk to advertise in the designated papers the week of October 3 to receive bids for a new 2010 or newer 4 wheel drive Loader for the Highway Dept. Bids will be received until October 21, 2010 at 2 p.m. at which time they will be opened and read. Bid specs may be obtained from the Town Clerk's office. The motion was carried.

Public Comment: John Manahan asked what the time was for the Public Hearing.
