## The Regular Meeting of the Town Board of the Town of Williamson was held in the Town Complex Court Room located at 6380 Suite II following the Worksession and was called to order at 7:30 PM on October 23, 2007 by Supervisor Hoffman with the Pledge of Allegiance. The following were

Todd Brennessel, Michael Bixby, Wilma Young, Eileen Loveman; Sun & Record, and the undersigned Town Clerk were also present.

A notice having been published for a Public Hearing on the Fire Protection Contracts for 2008, Supervisor Hoffman declared the Hearing open at 7:32 PM. The Supervisor explained the budget process for the three fire companies and the Rural Fire District. He also stated he was working with the Fire Commissioners on a project to combine four Fire Districts into three. This would eliminate the Rural Fire District. These Districts could still maintain their stations, fundraisers and volunteers. As no one wished to comment or ask questions, the Hearing was closed at 7:34 PM with a motion made by Councilman Verno, seconded by Councilman Warren. The motion was carried.

A notice having been published for a Public Hearing on the Preliminary 2008 Budget, Supervisor Hoffman declared the Hearing open at 7:34 PM. The Supervisor explained there would be a .95 per 1000 decrease in the 2008 Budget. The Board has committed to spending \$21,000 to pave the Town parking lot next to the old Town Hall up on Ridge Road, \$25,000 towards the expenditure in updating the Master Plan; which may take a couple of years and \$100,000 towards road improvements in the 2008 Budget. Supervisor Hoffman reported the budget included a 10% increase for electric, 12% increase for health insurance, 2.8% in employee salaries, 3.6% increase in judges salaries, no pay raise for the Board and Supervisor, \$1,000 increase for the aging, 18% increase for workman's comp., and \$1,000 set aside for a snow blower. As no one wished to comment or ask questions, the Hearing was closed at 7:52 PM with a motion made by Councilman Warren, seconded by Councilman Verno. The motion was carried.

Public comment: No one wished to comment.

Supervisor Hoffman made a motion, seconded by Councilman Verno, to accept the Consent Agenda containing the following items:

Supervisor Hoffman presented the following Resolution and moved its adoption. It was seconded by Councilman Verno.

WHEREAS: New York State's Medicaid program is the largest and costliest in the nation, and Medicaid waste, fraud and abuse are estimated to cost New York taxpayers nearly 4.5 billion annually, and

WHEREAS: Medicaid costs are the largest part of county budgets and waste, fraud and abuse consume a significant portion of these budgets, and

WHEREAS: New York counties require the means to investigate and combat Medicaid waste, fraud and abuse in their system, and should not be burdened by the cost of essential Medicaid fraud investigation software, and

WHEREAS: Assembly Minority Members have introduced Assembly Bill 5333 which provides reimbursable grants to counties for Medicaid fraud investigation software to review billings and discover potential waste, fraud and abuse, and this legislation would reimburse counties that have already purchased the software on their own, and

WHEREAS: Combating waste, fraud and abuse is a first step in fixing New York's broken Medicaid system and will provide counties and taxpayers vital relief from overbearing Medicaid costs,

NOW, THEREFORE, BE IT RESOLVED: That this Legislative Body pause in its deliberations to acknowledge New York State's Medicaid waste, fraud and abuse dilemma and urge the immediate passage and chaptering of Assembly Bill 5333 which will help local governments combat Medicaid waste, fraud and abuse, and

BE IT FURTHER RESOLVED: That a copy of this resolution, suitably engrossed, be transmitted to the Governor of the State of New York, the Temporary President of the New York State Senate, the Speaker of the New York State Assembly, and to each member of the New York State Legislature.

Councilman Warren made a motion, seconded by Councilman Verno, to authorize the Town Assessor to attend a WNY-IAAO seminar "Valuation of Wireless Communication Towers and Sites". The seminar will be held on Friday, November 9, 2007 at the Holiday Inn in Batavia. The cost for this seminar is \$75.00 and all other necessary and actual expenses will be a Town charge. The motion was carried.

Councilman Warren made a motion, seconded by Councilman Verno, to authorize the Town Supervisor to attend the Fall 2007 Regional Local Government Workshop. The seminar will be held on Friday, November 16, 2007 at the Genesee River Restaurant and Reception Center in Mt. Morris, New York. The cost for this seminar is \$40.00 and all other necessary and actual expenses will be a Town charge. The motion was carried.

Councilman Warren made a motion, seconded by Councilman Orbaker, to hire Bill Lamb, as a seasonal worker, for snow removal and salting of sidewalks at the Town Complex at the rate of \$9.00 per hour. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign a snow removal agreement with Williamson Central School. The agreement will be for the removal of snow from the sidewalk that goes from the four corners of Williamson to the High School at a cost of \$70.00 per trip. The Town will remove the snow and the school district is to pay one half of that cost (\$35.00). The motion was carried.
