# Local Law #2011-3 "Real Property Tax Levy Limit"

## Section 1. Legislative Intent

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Williamson pursuant to General Municipal Law §3-c, and to allow the Town of Williamson to adopt a budget for the fiscal year 2012 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

# Section 2. Authority

This Local Law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by the vote of sixty percent (60%) of the town board.

#### Section 3. Tax Levy Limit Override

The Town Board of the Town of Williamson, County of Wayne, is hereby authorized to adopt a budget for the fiscal year 2012 that requires a real property levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

#### Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, pr part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

### Section 5. Effective Date.

This Local Law shall take effect immediately upon filing with the Secretary of State.

Supervisor Hoffman presented the following Resolution and moved its adoption. It was seconded by Councilman Bixby.

WHEREAS: The Town Board has met at the time and place specified in the notice of hearing on the 2012 Preliminary Budget and heard all persons desiring to be heard thereon.

NOW, THEREFORE, BE IT RESOLVED: That the Town Board does hereby adopt such Preliminary Budget, pursuant to Section 109 of the Town Law, as the Annual Budget of this Town for the fiscal year beginning the first day of January 2012, and that such budget as so adopted be entered in detail in the minutes of the proceedings of this Town Board Meeting, and

BE IT FURTHER RESOLVED: That the Town Clerk of this Town pursuant to Section 115 of the Town Law shall prepare and certify, in duplicate, copies of said Annual Budget as adopted and deliver them to the Town Supervisor for presentation to the Board of Supervisors of Wayne County.

Councilman Verno amended the motion, seconded by Councilman Orbaker to change the Highway Superintendent salary from \$65,053 that included the added responsibilities to just the Superintendent salary of \$57,053. The amended motion was carried.

Discussion ensued. Supervisor Hoffman stated the budget had to be adopted by November 15<sup>th</sup> according to State law. Councilman Watson recommended that the Board review Mr. Gilges's presentation and move on the adoption of the budget at the next meeting. Councilman Watson made a motion, seconded by Councilman Orbaker to table the resolution. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Bixby, to authorize the Senior Account Clerk and Clerk to the Supervisor to attend the WC Bookkeeper Association continuing education class at the WC Public Safety Building, on November 16, 2011. The cost of the class is \$30.00 per person with all other necessary and actual expenses a Town charge. The motion was carried.

The Board discussed students participating on town boards. Councilman Bixby stated there are currently students on the Park and Recreation Committees who do not attend. Councilman Watson agreed to go back to the school and find out just how serious the students where about getting involved with local government.

Councilman Watson made a motion, seconded by Councilman Orbaker, for the Town Clerk to advertise for the upcoming opening on the Zoning Board of Appeals. The advertisement will appear in the designated Town papers the week of November 6, 2011 with applications accepted until December 2, 2011 at 4:00 PM. The motion was carried.

Councilman Watson made a motion, seconded by Councilman Orbaker, for the Town Clerk to advertise for the upcoming openings on the Planning Board. The advertisement will appear in the designated Town papers the week of November 6, 2011 with applications accepted until December 2, 2011 at 4:00 PM. The motion was carried.

Public Comment: No one wished to comment.
