Councilman Verno made a motion, seconded by Councilman Orbaker requesting the Clerk of the Board, in compliance with General Municipal Law 103, to advertise in the Williamson SUN issue of October 28, 2004 for bids as follows:

- Approximately 3,500 gallons of No. 2 Fuel Oil to be delivered as needed to a 1,000 gal. tank located at the Wastewater Treatment Plant.
  - Approximately 17,000 ± gallons of No. 2 Fuel Oil (winterized Diesel,

composition and/or percentage of blend to be stated) to be delivered as needed to a 2,000 gal. tank located at the Town Highway Garage, 3988 Ridgeway Street; and to a 500 gal. tank located at the Water Plant, Hamilton Street Ext.

- Approximately 35,000 ± gallons of unleaded plus gasoline to be delivered as needed to a 1,000 gallon tank located at the Town Highway Garage, 3988 Ridgeway Street, The bid documents will contain a non-collusion certificate. Price is to be based on their areas rack posting at the time of bid. Fuel bids will also contain a firm differential for each fuel bid. The contract will contain a clause to allow for price adjustments every two weeks as is standard with petroleum prices. The contract(s) will be in effect until December 31, 2005, and the Town Board has the right to reject any and all bids. Bid opening will be at 11:00 AM on Friday, November 12, 2004 at the Town Hall. The Board asked that the opening date be changed to Friday, November 12<sup>th</sup> but it has already been sent to the press. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign an agreement with the Williamson Business Improvement District for the removal of snow from sidewalks in the Business Improvement District by the Town of Williamson at \$70.00 each trip. Discussion ensued. The motion was carried.
