The advertisements will appear in the designated Town papers the week of November 7th, 2010 with applications to be accepted until December 3rd, 2010 at 4:00 PM. The motion was carried.

WHEREAS: A Local Law was adopted in 1997, to establish that license fees for dogs may be amended by resolution, and

WHEREAS: Any dog(s) four (4) months and older harbored in Williamson for more than thirty (30) days must be licensed, and

WHEREAS: All dog licenses are good for one (1) year from the original license date.

NOW, THEREFORE, BE IT RESOLVED: That the dog license fees are to be nine dollars (\$9.00) for a spayed or neutered dog and seventeen (\$17.00) for an unspayed or unneutered dog. The license fees breakdown includes:

- \$ 8.00 local fee for each spayed/neutered license plus the state surcharge.
- \$14.00 local fee for each unspayed/unneutered license plus the state surcharge

BE IT FURTHER RESOLVED: The following are additional dog fees:

- A purebred license local fee is \$25.00 plus the state surcharge for each dog.
- Replacement tag charge is \$3.00
- Service dogs must be licensed but will be exempt if providing a state certification plus the existing state surcharge for spayed/neutered or unspayed/unneutered dog.
- A Late charge of \$5.00 will be administered if license renewal is past sixty (60) days after two reminder notifications have been done.
- Must have veterinary certification if dog cannot be altered due to the health of the dog. The state surcharge will then be the same as a spayed/neutered dog.

BE IT FURTHER RESOLVED: That the Town mandates notification from all animal shelters of all dogs that are adopted into the Town of Williamson.
