Councilman Bixby made a motion, seconded by Councilman Verno, to authorize the Town Supervisor to sign a service agreement with Postler & Jaeckle Corp. for maintenance to the Aerco boiler system. The cost for this service will remain the same as last year at \$856.00. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Verno, to appoint Cindy Brand as the Sole Assessor for the Town of Williamson for a six year term which will begin on December 2nd, 2013 and expire on September 30th, 2019. Her rate of pay will be \$35,387 annually and will be prorated for the remainder of 2013. She will work less than 20 hour per week. The motion was carried.

Supervisor Hoffman made a motion, seconded by Councilman Verno, to authorize the Town Supervisor to sign an agreement with Raymond F. Wager to assist the account clerk in preparation of the AUD, as per agreement, not to exceed \$1,350.00. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Verno, to authorize the Town Supervisor to sign an agreement with the Williamson Recreation Committee to provide recreational programs for children and adults in Williamson as per agreement. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Verno, to authorize up to five Town of Williamson town employees, to attend the Association of Town's Annual Meeting in New York City to be held February $16^{th} - 19^{th}$, 2014. The pre-registration fee is \$100.00 per person. All other actual and necessary expenses are to be a Town charge. The motion was carried.

on the contract plans relating to the project and meeting the requirements of the owner, and

WHEREAS: The State will provide for the reconstruction of the above mentioned work, as shown on the contract plans relating to the above mentioned project.

BE IT FURTHER RESOLVED: That the clerk of the Town of Williamson is hereby directed to transmit five (5) certified copies of the foregoing resolution to the New York State Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED: That the Town of Williamson does hereby approve Change Order #1 to Wind-Sun Construction, Inc. for \$19,001.12 Roll call vote on the Resolution was as follows:

WHEREAS: This change order is for #1 – Ventilation Louvre Power and Controls, #2 Air Compressor Power Supply, #3 – Radiant Heater Draft Fan and Igniter Power Supply, #4 – Auger Control, Power Supply and E-Stop Switch, #5 – Installation of Heater Thermostat, #6 – Furnish and Install 15 Kva Transformer, #7 – Increase screw press electrical service to 100 Amps, #8 – Relocation of crane service feed from HBP-1 to HVP2,

NOW, THEREFORE, BE IT RESOLVED: That the Town of Williamson does hereby approve Change Order #2 to Connors-Haas, for \$20,965.06.

Councilman Orbaker presented the following Resolution and moved its adoption. It was seconded by Councilman Bixby.

WHEREAS: The Town of Williamson herein called the "Municipality", after thorough consideration of the various aspects of the problem and study of available data, has hereby determined that certain work, as described in its application and attachments, herein called the "Project", is desirable, is in the public interest, and is required in order to implement the Project; and

WHEREAS: The Environmental Conservation Law ("ECL") authorizes State assistance to municipalities for water quality improvement projects by means of a contract and the Municipality deems it to be in the public interest and benefit under this law to enter into a contract therewith;

NOW, THEREFORE, BE IT RESOLVED: By the Town of Williamson

1. That James D. Hoffman or such person's successor in office, is the representative authorized to act in behalf of the Municipality's governing body in all matters related to State assistance under ECL Articles 17, 51 and 56 and/or any applicable federal grant provisions. The representative is also authorized to make application, execute the State Assistance Contract, submit Project documentation, and otherwise act for the Municipality's governing body in all matters related to the Project and to State assistance;

- That the Municipality agrees that it will fund its portion of the cost of the Project and that funds will be available to initiate the Project's field work within twelve (12) months of written approval of its application by the Department of Environmental Conservation;
- 3. That one (1) certified copy of this Resolution be prepared and sent to the Albany office of the New York State Department of Environmental Conservation.
- 4. That this Resolution take effect immediately.
