WHEREAS: The Town Board of the Town of Williamson has reviewed the expenses incurred to the Town regarding the cost of providing medical benefits to the hourly employees, who work a minimum of 1040 hours but not more than 1559 hours per year, and

WHEREAS: The cost of providing the stipend for medical insurance is becoming increasingly cost prohibitive,

NOW, THEREFORE, BE IT RESOLVED: By the Town Board of the Town of Williamson, Wayne County, New York, as follows:

- Section 1. The Town of Williamson will no longer provide a medical benefits stipend for hourly employees hired after January 1, 2016.
- Section 2 . This resolution will modify and supersede Article XXVI Hospitalization and Medical Benefits, Section B, on page 39 of the Town of Williamson Personnel Policy
- Section 3. This resolution shall take effect immediately.

Councilman Orbaker made a motion, seconded by Councilman Watson, to direct the Town Clerk to advertise in the official Town papers the week of November 15, 2015 to receive applications for a seasonal laborer for the Highway Department. The position will be on an as needed basis with a rate of pay of \$15.00. Job duties can be obtained from the Superintendent of Highways. Applications will be accepted until December 3, 2015 at 4:00 PM. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign an agreement with Wayne County for snow and ice removal from County Roads in Williamson for the 2015 – 2016 season. The motion was carried.

Councilman Orbaker made a motion, seconded by Councilman Verno, to employ the engineering services of Larsen Engineers for plans and specifications for replacement windows for the Town Highway Garage. The cost for the engineering services are not to exceed \$1,600.00. The motion was carried.

Councilman Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Watson.

WHEREAS: Williamson is the first town in Upstate NY to obtain all energy for its town facilities from solar power, and the Town has successfully completed the 2015 Solarize program under the NYSERDA grant, and wishes to continue the Solarize program under phase II grant, by submitting an application for the 2016 Solarize New York follow up grant that is intended to focus on a Community Distributed Generation system , and

WHEREAS: The Town is fully committed to serve as the lead agency and bring together residents, local institutions, and small businesses who will be contacted regarding purchasing solar power in order to obtain a lower energy cost option that can reduce and fix their energy costs for a 20 to 25 year term. This approach will allow residents (who were not able to participate under the 2015 Solarize Williamson Program) a chance to participate as a member of the Community Distributed Generation Group, and

WHEREAS: The Town's diverse energy task force will work with the Center for Environmental Information and Larsen Engineers to implement a 2016 Solarize Williamson Community Distributed Generation campaign,

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Williamson hereby authorizes Larsen, at no cost to the Town, to prepare a grant application to NYSERDA to receive \$5,000.00 to subsidize the 2016 Solarize Williamson Community Distributed Generation campaign. The Town Supervisor is authorized to sign the grant application which must be submitted by November 16<sup>th</sup> 2015.

The cost for the engineering services are not to exceed \$7,500.00. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to attend the 12<sup>th</sup> Annual NYS Environmental Excellence Awards Ceremony to be held at the SUNY Polytechnic Institute in Albany, New York. There is no registration fee to attend this ceremony. All other actual and necessary expenses are to be a Town charge. The motion was carried.

Public Comment: Gryphen Akridge-Phillips asked the Board to consider looking into having the Apple Blossom Festival relocated at the Town Park on Eddy Road. She stated there would be more parking, public bathrooms available, more room for more vendors and more room for more rides. Supervisor Hoffman explained the request has been discussed in the past and that the Festival was under its own entity but he would pass the request on to the committee. Supervisor Hoffman made a motion, seconded by Councilman Verno, to pay the following bills as audited:
