The grant will be to purchase signs for the trails to improve recognition of where they are. The grant request is for \$1,230.00. The motion was carried.

Supervisor Hoffman made a motion, seconded by Councilman Orbaker, to authorize the Town Supervisor to sign a Compensation (Salary and Wage) Analysis Services Agreement with Public Sector HR Consultants upon approval of the Town Attorney. The total costs for these services will be \$12,500.00 dollars. The motion was carried.

BE IT FURTHER RESOLVED: That the Town Clerk is ordered to advertise in the appropriate papers the week of December 14, 2014 for said public hearing, and

BE IT FURTHER RESOLVED: That the Town Board instructs the Town Supervisor to serve a notice to the owners of said property, Beverly Grossman Credit Shelter Trust, 41A, 43rd Avenue, San Francisco, California, 94121, in accordance with Section 135-7 that they will be required to attend the Public Hearing and that they have to commence the amelioration of the code violations sited in the code officers report and that those repairs must be made no later than 60 days upon service of notice.

Councilman Verno made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign a Host Acknowledgment Agreement between the Town of Williamson and SSA Solar of NY, LLC upon approval of the Town Attorney. The motion was carried.

Councilman Verno made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign a Consent to Assignment Agreement between Sustainable Energy Developments, SSA Solar of NY, LLC and the Town of Williamson upon approval of the Town Attorney. The motion was carried.

Supervisor Hoffman stated the system is scheduled to be operational December 22, 2014.

Supervisor Hoffman reviewed the steps taken to address the safety concerns regarding NYS Route 104. – Requested a meeting with the NYS DOT to include Town Supervisors from Williamson & Sodus along with Board members, County Highway and Town Superintendents and any interested citizens, reinstituting the Wayne Co. Traffic Safety Board, and sent letters to law enforcement making them aware of the concerns.

Supervisor Hoffman recommended scheduling a "Document Shredding Event" annually to our residents at minimal or no cost to our residents. There is a company named "Eco Green Park" who offers this type of service. Discussion ensued.

Ram Shrivastava, P.E.; Larsen Engineers gave his recommendations based from the review and update of the energy conservation and sustainability study done in May 2010 at the Williamson Highway Garage. He felt that replacing the windows and installing exterior wall and ceiling insulation would greatly improve the energy efficiency.

Councilman Bixby made a motion, seconded by Councilman Orbaker, to pay the following bills as audited:
