Councilman Bixby made a motion, seconded by Councilman Gowan, to authorize the Town Supervisor to sign a service agreement with Postler & Jaeckle Corp. for maintenance to the Aerco boiler system. The cost for this service will remain the same as last year at \$882.00. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign a janitorial cleaning agreement with Coverall for janitorial cleaning services for the Town Complex. The cost for these services will be \$516.00 monthly which will include spring and fall cleaning. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Watson, to reappoint Jason Beardsley to the Park Committee. His term of office will be for three years, from January 1, 2018 to December 31, 2020. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Watson, to authorize the Building Inspector to attend a grant writing seminar to be held on February 8 and 9, 2018 at SUNY Oswego Metro Center in Syracuse, New York. The cost for the seminar is \$455.00 with all other actual and necessary expenses a Town charge. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Orbaker, to authorize the Senior Account Clerk to attend a Payroll Law seminar to be held on February 28, 2017 at the Radisson Hotel Airport in Rochester, New York. The cost for the seminar will be \$149.00 with all other actual and necessary expenses a Town charge. The motion was carried.

Supervisor Verno received a copy of a letter in which Senator Pamela Helming sent to the NYS Department of Environmental Conservation Executive Deputy Commissioner, Kenneth Lynch inquiring on the status of what that agency is doing to take preventative steps to prepare for another season of flooding in regards to Plan 2014. She also asked for a copy of the study to assess the recent water levels for Lake Ontario and the damage that resulted from the flooding done by the International Joint Commission [IJC].
