The Supervisor advised Town Board members that Ram Shrivastava, President and CEO of Larsen Engineering, has offered to prepare Request for Proposals (RFPs) for the Town of Williamson for NYSERDA approved developer/installers to submit bids to the town for NYSERDA funding for a solar panel project. The project would be located at the former landfill on Pound Round. It would be large enough to generate all the electricity needed for town-owned facilities. Larsen Engineering would review the RFPs and make a recommendation which submission would actually be forwarded to NYSERDA. If awarded by NYSERDA, this funding would result in a Power Purchase Agreement (PPA) for the town with the installer. The Town can reject all RFPs if it chooses. If there was consensus to go forward, there would need to be a Resolution at the January 8th Town Board meeting as bids are due at NYSERDA by March 5th. If funding should become available for wind power, another option to consider for the future is a wind turbine at the Waste Water Treatment Plant. The members agreed to go forward with the RFPs for the solar panel project. The Town Board requested that Mr. Shrivastava be present at the next Board meeting.

Councilman Bixby made a motion, seconded by Councilman Watson, to authorize the Town Supervisor to sign an agreement with Arthur Williams, Esq., Nesbitt and Williams, to provide legal services to the Town of Williamson from January 1, 2013 through December 31, 2013 and as per agreement. The charge to the Town will be \$165.00 per hour as per agreement. The motion was carried.

International 4300 Truck, and WHEREAS: The bid was examined to determine if it met all of the specifications of the bid requirements and was in the best interest of the Town, and

NOW THEREFORE BE IT RESOLVED: That the bid be awarded to STS Trailer & Truck Equipment as it met the specifications as required and therefore would be in the best interest of the town in the amount of \$37,500.00.

The cost for this service is not to exceed \$3,597.50 as per agreement. Superintendent Allman asked the Board to include in their service cutting up scrap culvert pipe for an additional \$800.00. Councilman Bixby amended the motion, seconded by Councilman Orbaker to change the cost for this service not to exceed \$4,500.00. The amended motion was carried.

Councilman Orbaker presented the following Resolution and moved its adoption. It was seconded by Councilman Bixby.

WHEREAS: Mott's LLP continues to expand their operation in Williamson providing positive support to the economy of the Town and Wayne County, and

WHEREAS: Since May 2008, the Town of Williamson has established a discounted water rate for Mott's LLP for all water used over 36 million

gallons per quarter,

NOW, THEREFORE BE IT RESOLVED: That beginning with the April Billing of 2013, Mott's LLP will be charged the rate of \$3.00 per thousand gallons, for the guaranteed purchase amount of 36 million gallons per quarter, and will receive a discount of \$.80 per thousand gallons for water used over that amount, in the quarter, at a rate of \$2.20 per thousand gallons,

BE IT FURTHER RESOLVED: That late charges will be assessed in the amount of 10% on any bill not paid before the penalty period of 30 days after bill date, and

BE IT FURTHER RESOLVED: The aforementioned rates will be in place through the billing of January 1, 2014 unless there is a major emergency affecting the ability of the Town of Williamson to provide water to the plant.
