Supervisor Verno declared the Hearing open at 7:31 PM. Supervisor Verno explained the change. No one had any questions or comments.

A notice having been published for a Public Hearing regarding Local Law #2-2017, amending Chapter 33, "Peddling and Soliciting". WHEREAS: The Pultneyville Players and PCLOC performed there in the 1960's and then in the early 1970's the Gatesinger Company LTD, was formed to add Broadway musicals to the season, and

WHEREAS: in 1984 the YouTHeater was created for the youth of the community to perform musicals, and

WHEREAS: Gates Hall is now owned by the Williamson-Pultneyville Historical Society and they are committed to preserving the historic integrity of the theater,

Councilman Bixby made a motion, seconded by Councilman Watson, to adopt proposed Local Law #1, 201, 7 Chapter 68 - Building Code Administration, Article IV – Permits. The motion was carried.

Local Law No. #1 of the year 2017

AMENDING: Chapter 68, BUILDING CODE ADMINISTRATION, ARTICLE IV – "Permits", Section 68-14 entitled "Permits Required"

ARTICLE IV

Permits

§ 68-14. Permit required.

- A. No person, firm, corporation, association or other organization shall commence construction, enlargement, alteration, improvement, removal, demolition, conversion or installation therein of any building or structure or change in use of the occupancy of any building or structure without first having applied for and obtained a permit from the Building Inspector. No permit shall be required for construction work that is not structural in nature and does not entail installation of plumbing, electrical, heating or ventilation systems or components in addition to such systems already in use. No permit shall be required for work of an ordinary or maintenance nature, except as otherwise stated in this chapter.
- B. No permit shall be required for:
 - (1) Construction or installation of one-story detached structures associated with one- or two-family dwellings or multiple single-family dwellings (townhouses) which are used for tool and storage sheds, playhouses, or similar uses, provided the gross floor area does not exceed 144 square feet (13.38 m²);
 - (2) Installation of fences which are not part of an enclosure surrounding a swimming pool;
 - (3) Construction of retaining walls unless such walls support a surcharge or impound Class I, II or IIIA liquids;
 - (4) Installation of window awnings supported by an exterior wall of a one-or two-family dwelling or multiple single-family dwellings (townhouses);
 - (5) Installation of partitions or movable cases less than five feet nine inches in height;
 - (6) Painting, wallpapering, tiling, carpeting, or other similar finish work;
 - (7) Installation of listed portable electrical, plumbing, heating, ventilation or cooling equipment or appliances;
 - (8) Replacement of any equipment, provided the replacement does not alter the equipment's listing or render it inconsistent with the equipment's original specifications; or
 - (9) Repairs, provided that such repairs do not involve:

- (a) The removal or cutting away of a load-bearing wall, partition, or portion thereof, or of any structural beam or load-bearing component;
- (b) The removal or change of any required means of egress, or the rearrangement of parts of a structure in a manner which affects egress;
- (c) The enlargement, alteration, replacement or relocation of any building system;
- (d) The removal from service all or part of a fire protection system for a period of time.

Councilman Bixby made a motion, seconded by Councilman Gowan, to authorize the Town Supervisor to sign an agreement with Pasco for an upgrade to the Alerton DDC control system for the Town of Williamson. The agreement will be for a new software program for the heating and cooling system of the Town Complex. The cost for the upgrade will be \$7,680.00 with an additional cost of \$1,200.00 for a new computer. The motion was carried.

Councilman Bixby made a motion, seconded by Councilman Orbaker, to direct the Town Clerk to advertise for the cancellation of the July 27th Town Board meeting. The motion was carried.

Supervisor Verno made a motion, seconded by Councilman Bixby, to authorize the Town Supervisor to sign a water/sewer budget review agreement with Bernard P. Donegan, Inc. for the 2018 water/sewer rate study. The cost for these services is not to exceed \$4,000.00. The motion was carried.

Supervisor Verno presented the following Resolution and moved its adoption. It was seconded by Councilman Bixby.

WHEREAS: A grant for salt storage is available through the New York State Department of Conservation (NYSDEC), and

WHEREAS: The Town of Williamson herein called the "Municipality", after thorough consideration of the various aspects of the problem and study of available data, has hereby determined that certain work, as described in its application and attachments, herein called the "Project", is desirable, is in the public interest, and

WHEREAS: The Town of Williamson agrees to the 25% match for the construction of a salt storage facility,

NOW, THEREFORE, BE IT RESOLVED: That the Town Supervisor is authorized to apple for a grant through the NYSDEC for the 75%/25% matching grant for a salt storage facility. Roll call vote on the Resolution was as follows:

Councilman Orbaker made a motion, seconded by Councilman Bixby, to authorize an unpaid leave of absent, for Doug Manktelow, to go into effect on August 4, 2017 until October 4, 2017. The motion was carried.
